Quick disposal of drawback claims has been a constant endeavor of this department. However, it is observed that in a large number of cases the drawback claims are pending as the replies to the queries raised by the department officers are not submitted in time/yet to be submitted. It has not been possible to settle these drawback claims for the want of replies to the queries raised which has resulted in backlog of around 9685 nos (Queries raised upto 31<sup>st</sup> March 2019) of drawback shipping bills.

2. The matter has been reviewed. With a view to ensure that the drawback claims are disposed off expeditiously and as a one-time measure to clear the pending drawback claims (Queries raised upto 31<sup>st</sup> March 2019) on priority basis, all the concerned Exporters/ Customs House Agents, are hereby requested to submit the replies to the queries latest by **30.11.2019**. If no reply is received by **30.11.2019**, the Proper Officer shall process/decide such drawback Claims on the basis of available records without any further reference to the exporters concerned.

3. All the exporters, Customs House Agents, are requested to take note for suitable compliance.
