**<u>Sub</u>**: Formation of Panel of Approved Valuers Appointment for valuing Gold, Silver, Jewellery, Precious Stones and Valuable Articles etc., - Reg.

Attention of the Importers, Exporters, International Passengers, Customs Brokers and all other Stakeholders is invited to this office Public Notice No.14/2021, dated.20.04.2021, read with Corrigendum dated. 10.05.2021, wherein application were called for appointment of approved valuers / appraisers for valuing Gold, Silver, Jewellery, Jewellery studded with Precious/synthetic Stones and Valuable Articles in the jurisdiction of Bengaluru Customs.

- 2. In this context, attention is also invited to this office Public Notice Trade Facility Circular No.04/2014, dated.17.11.2014, wherein approved valuers / appraisers for valuing Gold and Silver Jewellery as well as Jewellery studded with precious stones/synthetic stones, for export and import from Air Cargo Complex, Bangalore were appointed.
- 3. In accordance with this office Public Notice No.14/2021, dated.20.04.2021, a panel of Valuers/ Assayers is re-constituted based on the sound academic background, performance, expertise and experience in the required field. Accordingly, the following persons are appointed as

valuers / assayers for valuing Gold, Silver, Jewellery of precious metals, Jewellery studded with precious stones/synthetic stones, Valuable Articles etc., for import / export in the formations of the Airport and Air Cargo Complex Commissionerate, Devanahalli, Bengaluru and Bengaluru City Commissionerate, as well as for valuation of seized/ confiscated Gold, Silver, Jewellery of precious metals, Jewellery studded with precious stones/synthetic stones, Valuable Articles etc., in the jurisdiction of the Airport and Air Cargo Complex Commissionerate, Devanahalli, Bengaluru and Bengaluru City Customs Commissionerate:

- 4. The above Appointed Approved Valuers / Assayers, are required to adhere to the procedures, code of conduct, conditions of Professional Competence and Due Care, conditions of Information Management Independence and Disclosure of Interest, conditions on Gifts and hospitality, conditions on Remuneration and Costs Occupation, employability and restrictions as prescribed under this office Public Notice No.14/2021, dated.20.04.2021, otherwise they are liable for action as enumerated in the said Public Notice No.14/2021.
- 5. The above Appointed Approved Valuers / Assayers, are required to submit yearly performance report containing full description of the work attended by them such as Bill of Entry / Shipping Bill / Passport number, Date of attending the assaying, Passenger / Importer / Exporter Name,

Description of goods, Quantity of Goods, Declared / Assessed value of goods, Date of seizure (if relevant), Place of Assaying (Airport / ACC-Menzies/AISATS, Courier-DHL/EICI etc) or any other relevant

information. The same shall be submitted to the Principal Commissioner of Customs, Airport and Air Cargo Complex Commissionerate, Devanahalli, Bengaluru, before 30<sup>th</sup> of April of every financial year, so as to assess their performance and to decide whether they are fit for continuing in the panel of Valuers / Assayers in the next year.

## Service Fees payable:

6. The service fees to be charged by appointed assayer / valuer for valuation of any asset shall not exceed the amount calculated at the following rates:

Rates fixed for Assaying / Valuation				
Sl. No.	Assayed Value	Rate		
1.	On the first 5 Lakh of the assayed value	0.5 % of the value		
2.	On the next 10 Lakh of the assayed value	0.2% of the value		
3.	On the next 40 Lakh of the assayed value	0.1 % of the value		
4.	On the balance of the assayed value	0.05% of the value		

<sup>\*</sup> GST at the applicable rate is chargeable on the above Service Fee charged.

- 7. Where the amount of fees calculated is less than Rs.1000/-, the appointed valuer may charge Rs.1000/-.
- 8. The assayer / valuer shall charge for the service rendered as specified in this Public Notice or as notified by the Department from time to time. The Fees/Service charges as claimed by the assayer/valuer shall be borne by the Exporter/Importer/International passenger/ Customs Broker or any other stake holder as applicable. Department shall not be responsible for non-payment/short payment of fees for services availed in this regard by the Exporter/Importer/International passenger/ Customs Broker or any other stake holder. In respect of seized goods, confiscated consignments which are taken up for disposal by the Department, the charges shall be paid by the Department. The appointed valuer / assayer shall issue a certificate for having rendered the service and such certificate will be advisory in nature and shall not be binding on the Department.

9. This Public Notice supersedes all the Trade Facility Circulars / Public

Notices issued earlier on the subject matter.

10. The period of empanelment shall be for a period of 5 years with

interim review at the end of 3 years (extendable by two more years).

11. This Public Notice should be considered as Standing Order for the

concerned Officers and Staff of Airport and Air Cargo Commissionerate,

Bengaluru.

12. Difficulty, if any, faced in implementation of this Public Notice may
