2. The Export Promotion Cell situated in Bengaluru shall have jurisdiction over Districts of Bangalore Urban, Bangalore Rural, Tumakuru, Chikkaballapur, Kolar and Ramnagar.

3. The Export Promotion Cell situated in the Mangalore Customs House shall have jurisdiction over the Districts of Dakshina Kannada, Kodagu, Udupi and Uttara Kannada.

4. All the above mentioned Officers shall attend to work related to Customs in addition to their regular work.
