PUBLIC NOTICE No.8/2020

Sub: Amendment of Public Notice No. 03/2020 dated 24.03.2020 – “Trade Facilitation – clearance of Import Cargo – Possible delay in filing B/E due to precautionary measures on account of the outbreak of nCovid-19 – waiver of the late fee under Section 46 (3) of the Customs Act, 1962 -reg.

Attention of the Importers, Customs Brokers and all other stakeholders is invited to the Public Notice No. 03/2020 dated 24.03.2020 on the above subject.

2. Since, issue of this Public Notice, various facilities have been extended on 24X7 basis for the Trade clearance of cargo. Keeping in view the development since then, it is now decided to withdraw the said waiver of late fee, as under;

“The waiver of late filing charges will not be available with respect to Bills of Entry for which IGMs filed after 31st May, 2020. In respect of Bills of Entry filed for IGMs up to 31.05.2020, the general waiver shall cease to be available to Bills of Entry filed after 08.06.2020”

3. Accordingly the exemption from late fee conveyed vide the Public Notice No: 03/2020 dtd: 24.03.2020 stands with drawn w.e.f: 08.06.2020.

4. All the Trade Associations are requested to take note and publicize the contents of this Public Notice among their members / constituents. For departmental officers, this may be treated as Standing Order.

5. Difficulties, if any, faced in implementation of this Public Notice may be brought to the notice of the concerned jurisdictional senior officers of Customs.
