
In connection with updation of database of the Customs Brokers in the electronic format, to avoid mismatch of any data and for further confirmation, the following details are required to be furnished by all the Customs Brokers, who are operating in the jurisdiction of Bangalore Customs Commissionerate in terms of Regulation 9(1) or Regulation 9(2) of CHALR 2004 [currently under Regulation 7(1) or 7(2) (i.e. Form B or Form C) of CBLR 2013] to this office, immediately, on or before **17.03.2014**.

3. Name of parent Commissionerate ( if working under Form-C)
