Sub: Extension of validity of AEO Certificates for ease of renewal process – Reg

Reference is drawn to Para 5.1 of circular No.33/2016-Customs dt. 22.07.2016 amended vide para viii of Circular no. 03/2018-Customs dt.17.01.2018 which relates to "Validity of AEO certificate" and reads as, " The validity of AEO Certificate shall be three years for AEO-T1 and AEO-T2, and five years for AEO-T3 and AEO-LO"

2. Board vide Circular no. 10/2021 –Customs Dt. 24-05-2021(Copy enclosed) has decided to extend the validity of all the AEO certificates expired/expiring between 01.04.2021 and 31.05.2021 to 30.06.2021, except for the cases where the entity has been found ineligible for continuation under the AEO Programme.

3. All the Trade Associations are required to communicate the above to the notice of Members for claiming the benefit/facilitation.

4. Action to be taken interms of decisions taken in this Public Notice will be considered as Standing Order for officers/staff.
