Subject:- Extension of facility of Customs Clearance – reg

Attention of Importers / Exporters, Customs Brokers, General Trade, Participating Government Agencies (PGA) and all stakeholders is invited to the various measures taken from time to time by the Bangalore City Customs to facilitate fast clearance of goods.

2. In addition to the existing arrangements, it has been decided to extend the facility of Customs Clearance up to 10 PM in CONCOR Shed, Whitefield ICD on all days with immediate effect. Extended hours clearance facility will be available only for RMS facilitated Bills of Entry in Import Shed and Self sealed/ LCL cargo in Export Shed.
3. The CONCOR, Whitefield ICD is requested to provide adequate manpower, logistics, equipment and make necessary arrangements in an uninterrupted manner.
4. In case of any difficulty faced in the implementation of these guidelines, the same may be brought to the notice of the Additional / Joint Commissioner of Customs, ICD, Whitefield, Bangalore.
