In exercise of the powers conferred under sub-section (a) of Section 8 of the Customs Act, 1962 (52 of 1962), I, Shri. Sandeep Prakash, Commissioner of Customs, Bangalore hereby approve the Container Freight Station, located at the below mentioned premises, of M/s. Marigold Logistics Private Ltd., as 'Customs Area' for the purpose of loading of export goods and unloading of import goods, subject to the strict observance of relevant provisions of the Customs Act, 1962, rules and regulations made thereunder and instructions issued, in this behalf, by the Central Government and by the Commissioner of Customs, from time to time.

Description of the premises:-

All land and structure on the plot of land survey No. 17/1 , 17/2, 15/4 and 18/2, Kanekallu Village, Jadigenahalli Hobli, Hosakote Taluk, Bangalore 560067, measuring 6.12 Acres including the warehouse area measuring 2250 sq mts. and open yard of about 23000 sq. mts.

2. Further, in exercise of the powers conferred under sub-section(b) of Section 8 of the Customs Act, 1962, I hereby also specify the limits of the said Customs Area as under:-


Northern side: Government road

Southern side: Mud road , IOC and properties of Sri.N. Govindaraju & Sri.Sonnappa bearing Survey No. 18.

Eastern side: Government road

Western side : Land belonging to Sri. Dasarahalli Rangappa and Sri.Kanekallu Muruvappa bearing Survey No.12.
