Terms & Conditions

1. Quotation will be opened on the 13th Oct 2021 at 5 p.m.
2. Bidders have to arrange for the pickup of these items from the O/o Commissioner of Customs, 4th Floor, Annex Building, Queen's Road, Bangalore-560001 on 14.10.2021 failing which will disqualify the successful bidder. No cartage charges whatsoever will be paid. Labour etc. to be arranged by the firms.
3. Items are being offered as a whole lot not as individual. Bidders have to take all the dead items (complete e-Waste) and therefore selection of specific items is not available.
4. Bidders will be allowed to inspect all the dead items from 09.10.2021 to 13.10.2021.
5. Auction will be awarded to the bonafide firm who will quote the highest price of the items taken as a whole.
6. Successful bidder will have to make complete payment (as quoted by him in his quotation) in Cash. Firms will be allowed to take goods only after making complete payment.
7. The firm should have PAN allotted to them by the Income Tax Department and must submit a copy.
8. The firm should provide a certificate that "Firm will not misuse any data which is available/saved in the hard disk of the dead computers and will delete them if extractable Further the electronic waste should be disposed off in the eco-friendly manner if not used by the firm as per the extant guidelines of Ministry of Environment & Forest. Prospective bidders of such lots of hazardous waste/scrap batteries/e-Waste should be in possession of registration, valid on the date e-Auction and on the date of delivery, as recycler/pre-processor agency and a copy of the certificate must be submitted." This office of Commissioner of Customs will not be liable for any of the harm whatsoever caused to the third party due to use of these e-Waste items.
9. Bidders must be registered as a Recycler/Reprocessor/Dismantler of e-Waste with Central Pollution Control Board, Ministry of Environment, Forest and Climate Change, Government of India or with the State Pollution Control Board or Pollution Control Committee in case of Union Territories. Bids received from the firms other than so registered will be summarily rejected
10. Quotations received after the due date and conditional Quotations shall be summarily rejected.
11. Canvassing in any form at any stage is not allowed and will entail cancellation of the offer.
