**PUBLIC NOTICE NO. 11 /2022 DATED 27.09.2022**

**Subject: Non - submission of Shipping Bills for closure of outstanding entries with Bank authorities / Updation in EDPMS System- Request from Bank Authorities for cancellation of AD Code registration allotted by the Department -reg**

\*\*\*\*

This office is in receipt of references from Bank Authorities informing that there has been a spurt in the number of Shipping Bills pending in EDPMS System against the AD code mapped to the Bank. Further it has been informed that, an in-depth analysis in respect of the pendency in the EDPMS system and the Bank's extensive follow up with the customers for submission of export bills for closure of the outstanding entries has revealed that one of the main factors for the increase in pendency and non-closure of the outstanding entries is mainly on account of the following set of customers viz.,

- (i) customers who despite follow up have not been co-operating in clearing the pending Shipping Bills but have been generating new Shipping Bills against their AD code.
- (ii) Customers who have ceased their banking relationship but continue to use the Bank's AD Code registered in ICEGATE.

2. The matter has been examined and it is requested that the Exporters, Customs Brokers and other members of the Trade should submit the Shipping Bills / Export related document to the Bank Authorities for closure of entries in EDPMS System or provide a NOC for cancellation of AD code in the ICEGATE database. This will ensure that the Export related documents are submitted to the concerned Bank Authorities in a timely manner for updation in EDPMS System.

3. The Exporters, Customs Brokers and other members of the Trade are requested to take note of the above for immediate compliance.
