SUBJECT: Import of Covid related Goods-Creation of Task Force for swift clearance and safe-guard against unscrupulous Importers -Reg.

Attention of the Exporters, Importers, Customs Brokers and all other Stakeholders is invited to this office Public Notice No.11/2020 dated 26.03.2020, on the facilitation measures extended in view of Covid 19 pandemic.

2. In view of the second wave of the Covid 19 pandemic and due to the increased impact of Covid-19 situation in the Country, it is imperative to support the swift and scrupulous Customs clearance of consignments related to Covid 19 treatment. The Board vide letter F.No.450/153/2017-Cus-IV dated 21.04.2021, has issued instruction that these goods are to be cleared on top priority.

3. In the above context, the following Task Force is formed to monitor and expedite the scrupulous Covid related consignments:

4. The exporters / importers and stakeholders may contact in advance the Turant Suvudha Kendra for the work related to clearance and give the



The Turant Suvidha Kendra, under the guidance of the above mentioned Task Force will examine the import/export consignments which are requested for assigning priority clearance stating Covid 19 reasons and shall facilitate clearance on top priority. The Taskforce will make arrangements for 24x7 clearance.
