- ii) M/s FedEx shall maintain separate records (preferably electronically) of all such movements and shall submit to the Deputy/Assistant Commissioner of Customs, Courier Cell, International Courier Terminal, Bengaluru, as and when required.

- iii) M/s FedEx will seal the closed body vehicle in which such consignments are loaded with a one-time tamper proof seal in the presence of the Customs officer. At the time of receipt of vehicle at Cargo Village, KIA, Bengaluru, M/s.FedEx will unload the goods after due checking and will intimate to Customs if the seal is found tampered with.
- iv) M/s FedEx will maintain a record (preferably electronically) of all such consignments received at their premises at Cargo Village, KIA, Bengaluru, in the form annexed at Annexure B. This form will also include the details of handling of such consignments at their premises at Cargo Village, KIA, Bengaluru.
