Sub: IGST Scroll failures due to invalid IFSC Code - Reg.

Attention of the Exporters, Importers, Customs Brokers and all other Stakeholders is invited to the issue of IGST refund not getting credited to the Bank accounts of the claimant.

- 2. In the above context, it has come to the notice that a higher incidence of rejection of IGST Scrolls due to PFMS Errors i.e. Invalid IFSC code (TPE0014) is being noticed which is expected to increase further in future due to the ongoing bank mergers.
- 3. In this connection, the Exporters are advised to verify their existing Bank Account details in ICEGATE and add or update the details exactly matching to the details in their actual bank account, including Beneficiary Name, IFSC code, Name of the Bank, Account number etc., after merger of bank.
- 4. Further, it is noticed that IEC user registers at multiple locations with their bank account number for Export Promotion incentives like IGST refund, Drawback etc. Presently, IEC users are able to add/update their Bank details for Export Promotion Incentive (IGST Refund) and Authorized Dealer Code Registration (Drawback Claims) online in the ICEGATE portal. In this regard, step-wise procedure for updating / adding Bank details is enclosed to this Public for ease of reference. - 5. Action to be taken in terms of decisions conveyed in this Public Notice and the same should be considered as Standing Order for the Departmental Officers.
