Subject: – Submission of Application for fixation of Special Brand Rate of Drawback under Rule 7(1) of the Customs, Central Excise Duties Drawback Rules, 2017 read with Section 75 of the Customs Act 1962 and request for condonation of delay in filing the drawback applications - Reg.

Attention of all the Importers, Exporters, Customs Brokers and all other stakeholders, is invited Rule 6(1)(a) and 7(1) of the Customs, Central Excise Duties Drawback Rules, 2017.

2. It is observed that the exporters are routinely filing the applications for sanction of drawback under Rule 6(1)(a) and 7(1) of the Customs, Central Excise Duties Drawback Rules, 2017 beyond the time limit specified, i.e. 3 months from the date of Let Export Order of the Shipping Bills and seeking for condonation in terms of the Rule 6(1)(a)(iv) and 7(1)(iv) of the Customs, Central Excise Duties Drawback Rules, 2017. Therefore, such delay in filing application a routine way should be avoided by the exporters. The application should be filed in time and only in 'exceptional' cases the delay will be condoned.
3. All trade associations /members of Customs Brokers Association are requested to take note and publicize the contents of this Public Notice among their members/constituents.

4. Action taken in terms of decision taken in this Public Notice will be considered as Standing Order for all officers / staff.
