Subject: Customs-Quick disposal of Drawback Claims Pendency for Query Reply-reg

Quick disposal of drawback claims has been a constant endeavor of this department. However, it is observed that as on 20.08.2021, 18676 nos of Shipping Bills of Air Cargo Complex, (ACC), Devanahalli, Bangalore are pending in Drawback Query to be finalized for want of replies from the exporters for the queries raised by the Proper Officer at Air Cargo Complex, Bangalore. The said queries are pre-dominantly pending for want of compliance for the queries from the exporters.

2. The matter has been reviewed, with a view to ensure that the drawback claims are disposed off expeditiously and as a one-time measure to clear the pending drawback claims on priority basis. The Exporters, Customs Brokers and other members of the Trade, are requested to submit their replies for the queries immediately and in no case not later than by 30.11.2021. It may please be noted that in case no reply is received for the query by 30.11.2021, the pending drawback Shipping Bills will be processed by the Proper Officer, on the basis of available documents, by following normal procedure.

3. The Exporters, Customs Brokers and other members of the Trade are requested to take note of the above for immediate compliance.
