Sub: Changes to the Harmonized System with a total of 351 amendments at the six digit level - w.e.f. 01.01.2022 - Reg

Attention of the Importers, Exporters, Courier Companies, Custodians, PGAs, Trade and Industry Associations and other Stakeholders invited to a wide range of changes to the Harmonized System.

2. The new (seventh) edition of the Harmonized System (HS) nomenclature, HS-2022 shall come into force from <u>1st January, 2022</u>. This edition has introduced significant change to the Harmonized System with a total of 351 amendments at the six-digit level, covering a wide range of goods moving across borders.

3. Also, for ease of transition to the HS-2022, a guidance document on correlation has been prepared by CBIC. The document can be accessed under the head – "Manuals" under the tab – "Customs on the CBIC website.
