<u>Subject</u>: - AEO - Details required in the solvency certificate to be furnished from the Chartered Accountant along with AEO applications (AEO-T2, T3 & LO)-Reg.

Attention of the Importers, Exporters, Courier Companies and all other Stakeholders is invited to the CBIC's Cirucular No. 33/2016, dated. 22.07.2016, as amended, issued regarding facilitation of Authorised Economic Operator ("AEO" for short) programme.

- 2. In this context, during the AEO Samvad Meeting held on 25.11.2020, it was deliberated and decided that the solvency certificate to be submitted for the AEO application should be in line with the requirements of AEO Circulars and should contain the following basic details for the last three financial years:
  - i. Net Worth figures.
  - ii. Figures of current assets and current liabilities.
  - iii. EBIT figures (Earnings before interest and taxes) for calculation of the current ratio.
  - iv. Declaration with respect to the applicant not involved in insolvency or bankruptcy proceedings.
  - v. Declaration stating that applicant has not defaulted in payment of due Customs duties during the past three years.

vi.Identification number of the Chartered Accountant.

- 3. Accordingly, all the AEO applicants are requested to take note of the above cited requirements while submitting the application for AEO status.
