**Public Notice No 10/2020 –Bengaluru Customs Zone**  
**[DIN: 20200772MR00009FCF4D ]**

Reference is invited to this office Public Notice No 07/2020 dated 06.06.2020 on the subject of faceless assessment. A Circular No.34/2020-Customs (F. No.450/26/2019-Cus IV(Pt.) Dtd: 30.07.2020 was issued by Central Board of Indirect Taxes & Customs conveying, *inter alia*, the commencement of the **2<sup>nd</sup> phase of All India roll out of Faceless assessment w.e.f. 03.08.2020**. The scope of faceless assessment at Bengaluru Customs Zone has also been extended to commodities falling under the Chapter 50 to 71 & 89 to 92 of the Customs Tariff Act, 1975.

2. It is pertinent to mention that the imports already covered under the 1<sup>st</sup> Phase would continue and be treated as subsumed under the 2<sup>nd</sup> phase. Thus, the 2<sup>nd</sup> phase of Faceless Assessment will cover the commodities falling under the following specified imports primarily under the specified Chapters of the Customs Tariff Act, 1975:-

3. The organization set up, the procedure, the role of the TSK etc. as published vide the earlier Public Notice No. 07/2020 dtd: 06.06.2020, will remain the same.

4. Further, for monitoring and ensuring speedy and uniform assessments with regard to Bills of Entry assigned by the Customs Automated System to the officers of the Faceless Assessment Groups (FAG), the Board has nominated the following officers as Nodal Commissioners :-

4.	Principal Commissioner/Commissioner of Customs (VII), Air Cargo Complex Chennai.
5.	Principal Commissioner/Commissioner of Customs, ICD Tughlakabad, Import.
6.	Principal Commissioner/Commissioner of Customs, Air Cargo Import, Delhi.



5. Further, a Notification No.63/2020-Customs (N.T.) dated 30.07.2020 was issued for the purpose of empowering the jurisdictional Commissioners of Customs (Appeals) at Bengaluru, Chennai and Delhi to take up appeals filed in respect of Faceless Assessments pertaining to imports made in their respective jurisdiction even though the assessing officer may be located at the other Customs station. To illustrate, Commissioners of Customs (Appeals) at Bengaluru would decide appeals filed in respect of the imports at Bengaluru though the assessing officer is located at Chennai/Delhi.

6. All other clarifications and guidelines on Faceless Assessment, as provided vide Circular No.28/2020-Customs and Instruction No.09/2020-Customs, both dated 05.06.2020, have no change.
