Subject: Mandatory additional qualifiers in import declaration in respects of certain products- reg.

The attention of Importers, Customs Brokers, Warehouse licensees, members of the trade and all other stakeholders are invited to the Board's Circular 15/2023-Customs dated 07.06.2023, Circular 18/2023- Customs dated 30.06.2023 and Circular 23/2023- Customs dated 30.09.2023 on the above subject.

2. To implement para 4 of the above circulars, the system has enabled tocapture an alpha numeric code identifier for commodities imported under Chapters28, 29, 32, heading 3808 and chapter 39 of the Customs Tariff Act, 1975, at the itemlevel in the Bill of Entry filed in the EDI System w.e.f. 15th October 2023. Accordingly, for identifying the Chemical category, the importers or Customs Brokers are mandatorily required to declare one of the chemical categories for those identified CTHs under the Single Window tables (SBE_ITEM_SW_INFO_TYPE and SBE_ITEM_SW_CONST) of the Bill of Entry at item level with following details:

- **4.** In case of non-availability of information for even one ingredient with the importer for the reason that information is not shared by the supplier due toconfidentiality, a self-undertaking is to be provided in the Bill of Entry by theimporter under Statement Code PC002 as follows:
