Attention is invited to CBIC Board's letter F.No.450/38/2021-Cus-IV dated 06<sup>th</sup> April 2021 on the reports on clearance of Bills of Entries at odd hours. In this regard Board has issued certain directions to be followed by the concerned officers.

- 2. No Customs Officers shall be at office working late after office hours and especially at odd hours (Between 10 PM and 8 AM). For any emergency, if such work is required to be attended to, then it shall be done with the approval of the Additional/Joint Commissioner. All the supervising section heads shall keep a strict vigil especially at ICD and PAD. A register shall be kept in the office with the DC/AC in which late night work if any attended is recorded. The register shall be periodically monitored by the Controlling Officer and reported periodically to Commissioner.
- 3. All the concerned officers are directed to implement the directions carefully.
- 4. Any difficulties faced by the officers may be brought to the notice of the Joint Commissioner of Customs, City Customs, Bengaluru.
