Please refer to the RTI application dated 17.01.2023 received in this office on 02.02.2023 as detailed above filed by you.

In this regard, the point-wise reply is as follows:

1) (i) Wherever SION permit use of either (a) Generic input or (b) alternative input, unless the name of the specific input together with quantity (which has been used in the manufacturing of the export product) gets indicated / endorsed in the relevant shipping bill and these inputs, so endorsed, within quantity specified and match the description in the relevant bill of entry, the concerned authorization will not be redeemed. In other words, the name / description of the input used (or to be used) in the authorization must match exactly with the name / description endorsed on the shipping bill. While all the DFIA licenses and the shipping bills we checked in the market are endorsed as Milk and Milk products, a generic input, instead of specific input used while manufacturing the export product such as biscuits and so on. Our query is whether we can use these DFIA licenses, which are endorsed as Milk and Milk products, for the import of Whey Protein Concentrate 80% (WPC 80%) and Whey Protein Isolate (WPI) under HS Code: 35022000.

Reply-No such information is available with this office.
