To minimize the physical human contact during this period, the matter was discussed with Mr. Sharief , in-charge of the Service Centre, and it is decided that the Trade shall make request, either by email at the email address or by sms/WhatsApp to the staff of CMC Service Centre at ICD/Whitefield by specifying the BE no. and BE date after the grant of OOC, for obtaining print out of the final bill of entry.
