Sub: IGST refunds on exports-extension in SB005 alternate mechanism- reg.

The attention of the Exporters, Customs Brokers, Custodians and all the stakeholders kind reference is invited to Board's Circulars 08/2018- Custom dt 23.03.2018, 15/2018- Custom dt 06.06.2018, 22/2018-Cus dt 18.07.2018, 40/2018-Custom dt 24.10.2018 and 26/2019-Cus dt 27.08.2019 and Circular No.22/2020-Customs dt 21.04.2020 on the above subject of SB005 error resolution. Whereas now CBIC vide Circular No.22/2020-Customs dated 21.04.2020 has extended the facility of SB005 error correction in the Customs EDI system for Shipping Bills with a date up to 31.12.2019. Further, all the Exporters/Importers, Customs Brokers, Other stakeholder and member of trade are informed that to dispose of pending refund claims, drawback and for disposal of IGST Refunds stuck up due to different errors, Special drive has been launched up to 30.04.2020 at Customs Commissionerate, Bangalore (Refer to CBIC Instruction No. 03/2020-Customs dated 09.04.2020 and PN No.20/2020 dated 23.04.2020)

2. For speedy processing of all the pending IGST refund claims due to SB005 Error pending, the Exporters are advised to furnish requisite documents/information to the concerned Asst./Deputy Commissioner (IGST refund) on priority as per the above-mentioned Circulars via email @ icdblr16@gmail.com. The contact details of Officers of ICD/Whitefield, for resolution of SB005 Error, are as under.

The list of pending IGST Refunds due to SB005 Error is enclosed as Annexure-A and also made available on the website of Bengaluru City Customs.

4. All the CHA/ Trade associations/ Representatives are advised to inform the exporters about the documents required for rectification of SB005 Errors for early resolution of errors through officer interface.
