It is for the information of all importers/exporters availed/availing Advance Authorizations (DEEC/DFIA Licence) / EPCG Licence that the list of Advance Authorizations (DEEC/DFIA Licences and EPCG Licences issued from various offices of JDGFT and registered at ICD, Whitefiled, Bengaluru (INWFD6) which are pending closure due to non-receipt of Export Obligation Discharge Certificate / Redemption letter issued by JDGFT, is made available in the website of Bengaluru Customs. https://bangalorecustoms.gov.in).
- 3. The Importers, Exporters, Customs Brokers and all other stakeholders are hereby advised to submit a copy of Redemption Certificate/EODC in respect Advance Authorizations (DEEC/DFIA Licences) and EPCG Licences pertaining to them, without delay for cancellation/closure of Bonds/release of BGs as well as smooth clearance of live consignments.
- 4. It is brought to the notice that licence holders can submit copies of Redemption Certificate/EODC and other related documents (listed at Para 4.1 and 4.2) to the Superintendent of Customs, ICD, Whitefield, Bengaluru or shall scan and send all the related documents to the officer listed below, for initiating necessary action:

It is also brought to notice that in the cases where export obligation period is over, the Licence holders are required to submit evidence of the fulfilment of an export obligation or proof of documents submitted to JDGFT, as per Board's Circular No.16/2017 dated 02.05.2017 to avoid action under Section 142 of Customs Act, 1962.
- 6. Action to be taken in terms of decisions conveyed in this Public Notice should be considered as Standing Order for officers.
- 7. Any difficulties faced may be brought to the notice of the Joint Commissioner of Customs, ICD, White filed, Bengaluru.
