Kind attention of the importers, exporters, Customs Brokers and all other stake holders is invited on the above cited subject. Please refer to the Public Notice No. 45/2020 dated 04.09.2020 on the subject.

- 2. It has come to the notice that a higher incidence of rejection of IGST Scrolls due to PFMS Errors i.e. Invalid IFSC code (TPE0014) is being noticed which is expected to increase further in future due to the ongoing bank mergers.
- 3. In this connection, The Exporters whose earlier banks merged are advised to verify their existing Bank Account details in ICEGATE and add or update the details exactly matching to the details in their actual bank account, including Beneficiary Name, IFSC code, Name of the Bank, Account number etc. after merger of bank. Every IEC user registers themselves in multiple locations with their bank account number for Export Promotion incentives like IGST refund, Drawback etc. Now, IEC users will be able to add/update Banking details for Export Promotion Incentive (IGST Refund) and Authorized Dealer Code Registration (Drawback Claims) online.
