Subject:- Customs: Public Notice in r/o import clearance of COVID related materials at HAL Airport-reg.

* * * * *

Kind attention is invited to the COVID-19 situation all over India. In these difficult times, with concurrence from Chief Commissioner, Customs Zone, Bengaluru, the Commissioner City Customs, Bengaluru, will facilitate the import of emergency COVID-19 related materials through HAL, Old Airport, Bengaluru and makes the following order, if the situation arises.

2. The HAL Old Airport is designated as Customs Airport under Section 7 of Customs Act, 1962. However from May, 2008 onwards after Bangalore Airport at Devanahalli was made operational, the HAL Airport was made operational round the clock only for non-scheduled, military cargo/logistics, and VIP aircraft movements and as a diversion alternative to Kempegowda International Airport in case of emergencies.

3. To facilitate the Import of Goods meant for COVID -19 care, like raw materials for COVID Vaccine manufacture and other relief material like in Oxygen Cylinders, Medicines, etc., pertaining to COVID care, other machinery meant for COVID care may be imported at HAL Airport. The CHAs/Importers are permitted to file the Manual Bills of Entry in respect of the COVID related relief materials as mentioned above under Section 46 of Customs Act, 1962, **if such cargo arrives at HAL airport.**

4. Following Customs officers are nominated to cater to the clearance of COVID-19 related emergency Imports if any at HAL Airport. The trade may contact the designated officers for such clearances on the following:
