Reference is invited to the ICES Advisory No. 32/2020 dated 13.09.2020 describing therein the various facets of Faceless Assessment in ICES. In this regard, various additional features have been enabled in ICES in order to further streamline the assessment process. In addition, certain clarifications are being provided herewith for more clarity.

- 2) Masking of SSO ID of the Customs officer
- 3) Identification of Bills of Entry filed by AEO
- 4) Limit on setting aside of Bills of Entry by VDC
- 5) Enhancements in the Dashboards for NAC and Reports for VAO and VDC
- 6) SMS Alerts to VAO/VDC
