Attention of all Importers/ Exporters / Customs Brokers, Members of the Trade bodies and general public is invited to the CBEC Circular No. 07/2020 - Cus dated 05.02.2020 issued by Central Board of Indirect Taxes & Customs & further directions issued from office of the Chief Commissioner of Customs, Bengaluru Zone, vide General Order C. No. VIII/48/302/2016 CCO II (BZ) dated 12.02.2020 and subsequently Public Notice No. 35/2020 dated 03.06.2020 and addendum to Public Notice dated 03.07.2020, issued by this office, regarding valuation of second-hand machinery.

- 2. Examination of goods requires high degree of professional expertise, integrity and fairness. Customs may refer consignments to them seeking expert opinion on valuation of subject goods. In the case of second hand / old & used machinery, equipment, other capital goods, computers, photocopiers/MFDs, office equipment, tools etc. and their parts/accessories, the empanelled Chartered Engineers are required to prepare their report in accordance with CBEC Circular No. 07/2020 dated 5<sup>th</sup> February, 2020 after verification of the goods.
- 3. In this connection, based on the sound academic background, performance, expertise & experience in the field of Valuation of Second-hand machinery, the following Chartered Engineers **enclosed herewith vide Annexure I** of this Public Notice, are empaneled for examination/valuation of Second / Old & Used machinery/goods etc. in the jurisdiction of Bengaluru City Customs Commissionerate and Principal Commissionerate of Airport & Air Cargo Complex, Bengaluru.
- 4. The Chartered Engineers empaneled by the Commissioner of Customs, Bengaluru, are required to prepare their report with Professional expertise, integrity and fairness and as per the instructions contained in CBIC Circular No.07/2020-

Cus. Dt. 05.02.2020 read with Public Notice No.35/2020 dated 03.06.2020, issued by this office, after thorough verification/examination of goods.

- 5. Further, they are required to submit yearly Self Appraisal Report containing the full description of the machinery examined and the value appraised by them and submit the same to the Commissioner of Customs before 30th April of every financial year so as to assess their performance and to decide as to whether they are fit for continuing in the panel of Chartered Engineers in the next year.
- 6. If self-appraisal is not submitted in time or if they are found involved in any offence relating to Customs classification/valuation etc., their empanelment is liable to be withdrawn.
- 7. The importers/Custom Brokers may make use of the services of any of the empaneled Chartered Engineers for the valuation of the machinery/goods referred by the Customs Department. The service charges claimed by the Chartered Engineers for the valuation done by them shall be borne by the importers. At the same time, the certificate issued by the empaneled engineers will be advisory in nature and shall not be binding on the department.
- 8. This Public Notice supersedes all earlier Public Notices issued by this office regarding empanelment of Chartered Engineers.
- 9. The period of empanelment shall be for a period of 5 years with an interim review at the end of 3rd year (3 years extendable by 2 more years).
- 10. The contents of this Public Notice may be publicized and brought to the knowledge of the member constituents of the Trade.
