**Eligibility: -**

- (i) Employee of the CB and Authorized Couriers licensed / registered duly approved by Deputy Commissioner of Customs or Assistant Commissioner of Customs who have passed 10+2or equivalent exam and having valid Aadhar Card are eligible to apply for the exam as provided under Regulation 13 of Custom Broker Licensing Regulations, 2018.
- (ii) While sponsoring the names of employees for the G-Card examination. the concerned CBs and Authorized Couriers licensed / registered are instructed to sponsor the names of only those employees who are eligible to take up the examination. The applications in the format appended to this Public Notice as Annexure-A may be submitted in the office of Commissioner of Customs, Bengaluru City Commissionerate, Technical Section, C. R. Building, 4<sup>th</sup> Floor, Queen's Road, Bengaluru 560001, on all working days up to 25.02.2022 till 1800 hrs. The candidates are advised to fill in all required details without altering the Proforma for submitting the applications.
- (iii) After getting the applications of the eligible candidates, the list of such applicants may be submitted by CBs and Authorized Couriers licensed / registered to this office in the following format along with the concerned applications, which are to be filed by each employee in the prescribed format stated in this Public Notice.
