Attention of the Customs Brokers is invited to the above mentioned subject. The Customs Brokers are hereby informed that the Mumbai Customs Zone – I is developing an all India based software known as “Customs Broker Licensing and Management System” (hereinafter referred to as “CBLMS”, in short) in association with NIC-SI. It is a Central Platform for managing the Customs Broker and their licensing process with end to end IT integration and smart automation.

In this regard, the Mumbai Customs Zone – I require basic data of Customs Brokers for providing login credentials to them in CBLMS. Hence, it is requested that all Customs Brokers operating under sub-regulation 2 of Regulation 7 of the Customs Brokers Licensing Regulations, 2018 (or corresponding provisions of earlier Regulations) in Bangalore Customs Commissionerate to provide updated error-free requisite data (i.e., active email id and active mobile number without any syntax error) along with other details in the prescribed proforma enclosed to this notice for updating the same in common portal (i.e., EDI system).
