## PUBLIC NOTICE NO. 1 /2022

Sub: Notice for Customs Brokers Examination, 2023-Reg

The written examination of Customs Brokers Licensing Examination, for the Year 2023, shall be conducted by NACIN in the month of **March-**2023 at the designated examination centers across India.

- 2. Complete application is to be submitted in person or by Registered/Speed Post in Form-A (available in the CBLR, 2018) along with two passport size photos and self attested documents on citizenship (Aadhar/ Passport/Voter card), educational qualification, financial viability, mobile number, email id and other requirements along with the prescribed fee of Rs. 500/- (Rupees five hundred only) to the Commissioner of Customs, Mangaluru Customs Commissionerate, Mangaluru, from 18.10.2022 to 18.11.2022 up to 06.00 PM. Applications sent by post, in case received after the last date shall not be entertained.
- 3. Before submitting the application, applicant should ensure the completeness of the application. Incomplete applications shall be summarily rejected.
- 4. The online written examination will be a Computer Based Exam with Multiple Choice Questions (MCQs) of two and half hours (10:30 hrs to 13.00 hrs) duration. Questions will be bilingual i.e., in English and Hindi. The pattern of the examination will be as follows:

5. The Syllabus of examination is prescribed in Regulation 6(7) of Customs Brokers Licensing Regulations, 2018, as amended. Those qualifying in the said examination will have to appear for oral examination in terms of Regulation 6 of the said Regulations.

- The oral examination will be held during the second quarter of the calendar year 2023. The pass percentage marks for qualifying in the oral examination will be 60%.
- 7. Attention is invited to the Guidelines dated 29.08.2018 issued by the Ministry of Social Justice and Empowerment, Department of Empowerment of Persons with Disabilities (Divyangjan) and circulated by CBIC vide letter dated 10.10.2018 pertaining to the persons with benchmark disability. It is hereby advised that eligible candidates meeting these criteria of benchmark disability and willing to avail the benefit of these guidelines should appropriately intimate about their eligibility and willingness so that necessary arrangements can be made by the exam conducting authority and its partner agencies.
- 8. A dummy question paper for the purpose of awareness of candidates will be available on the CBIC and NACIN websites <a href="www.cbic.gov.in">www.cbic.gov.in</a> and <a href="www.nacin.gov.in">www.nacin.gov.in</a> under the icon/tab <a href="grap-color: GSTP/CBLR EXAM">GSTP/CBLR EXAM</a> FROM February 2023. A link to download the admit card will also be provided therein. Admit card shall also be sent by email to eligible applicants 12 days in advance before the date of examination. For convenience of candidates, other necessary details like list of centers, guidelines to the candidates, help desk, email id. Etc., will also be made available under the said icon/tab.
