- 3. The meeting commenced with a welcome note by the Chairman. The Deputy Commissioner (CCO) Bengaluru Customs Zone made a presentation on the recent Board Circulars, advisories issued by DG Systems and public notices of the Commissionerates under Bengaluru Customs Zone issued during the period from 28th March 2023 to 28rd May 2023.
- 4. The Deputy Commissioner mentioned that there are no agenda points received. Chairman allowed for any points to be taken up as no agenda points were received. The issues discussed are as follows:
 - a. Chairman informed that the New Custodians, viz., WFS and Menzies have started operations from 24th May onwards and accordingly they will be invited to the next CCFC and PTFC meetings. The details of the Custodians to be put up the Chief Commissioner, to include them for the next CCFC meeting.
 - b. V Chandru, Vice Chairman, Air Cargo Forum India has informed that Animal quarantine have moved their facility to Hesaraghatta, Bengaluru and that shipments like Live animals, Pets and some goods requiring AQCS clearance are being sent for testing followed by AQCS clearance and hence increase in dwell time. They have requested for posting of one AQCS officer at AP&ACC to reduce the Dwell time. Chairman has stated that representation will be forwarded from the CCO.
 - c. Girish Narayan, Secretary, Bangalore Custom House Agents Association Limited requested for conducting G-card and F-Card exam. Additional Commissioner, City Customs Commissionerate requested to provide data regarding no. of G-card and F-Card Holders number required for customs work against statistics of existing no. to take up the issue.
 - d. Girish Narayan, Secretary, Bangalore Custom House Agents Association Limited stated that they have written letter to CONCOR regarding some issue pertaining to CHAs. Additional Commissioner, ICD Bengaluru informed that reply from CONCOR has not been received till date and hence the issue will be taken up after receipt of the same.
 - e. P Dorababu Assistant Director, AEPC thanked Principal Commissioner, AP&ACC for timely intervention in the issue of M/s Texport and informed that the issue has been resolved.
- 5. The Chairman thanked the participants and concluded the meeting.
