NOTIFICATION ISSUED UNDER SECTION 8 OF THE CUSTOMS ACT, 1962

Notification No.01/2024 (N.T.)

In exercise of the authority conferred upon me under sub-section (a) of Section 8 of the Customs Act, 1962 (52 of 1962), I, Amitesh Bharat Singh, Commissioner of Customs, Bengaluru City Customs, Bengaluru, hereby declare and notify the designated 'Customs Area' at the Inland Container Depot operated by M/s. Adani Logistics Limited. This notification regarding the 'customs area' is issued with the explicit intent of streamlining and facilitating the process of loading export goods and unloading imported goods. The designated 'customs area' is described as follows:

Description of the Premises:

The premises encompass all the land and buildings situated on the parcel of land identified by Plot Sy. Nos. 147/2, 145, 113-1&2, located in Dyapasandra village road, near Malur railway station, Malur, Kolar District, Karnataka-563130.

The total terminal area measures 25 acres out of which 11 acres for customs bounded area, inclusive of a covered warehouse spanning 994 square meters (10699 square feet).

Furthermore, in the exercise of the authority vested in me by sub-section (b) of Section 8 of the Customs Act, 1962, I hereby delineate the boundaries of the designated Customs Area as follows:
