M/s. Express Industry Council of India (M/s. EICI), was appointed as "Custodian" in respect of Courier consignments that are imported or exported or transshipped through "Express Industry Council of India Courier Facilities" at Plot No. C-19, Express Cargo Terminal, Survey No. 90, 180, 181, 182, 183 & 197, Kempegowda International Airport, Bengaluru, vide Public Notice No.35/2021-AP & ACC dated 17.11.2021 for two years. The area was declared as Customs Area under Section 8(a) of Customs Act, 1972 vide Public Notice No.36/2021- AP & ACC dated 17.11.2021. The Custodianship was further extended upto 17.03.2025 vide Public Notice No.07/2024 dated 31.07.2024.

- 2. M/s. Express Industry Council of India vide letter dated 18/01/2023 has sought permission for reengineering EICI Common User Express Terminal at Express Cargo Building, Bengaluru Airport from 25000 square feet to 15761 square feet. The permission for re-engineering was granted by Principal Commissioner of Customs, Airport and ACC Commissionerate on 21/02/2023. Upon completion of the reengineering activity, M/s.EICI has sought approval for commencement of import and export operations from the newly re-engineered area.

In exercise of the powers conferred under Section 8 (a) & (b) of the Customs Act, 1962, I, KAJAL SINGH, Principal Commissioner of Customs, Airport and Air Cargo Commissionerate, Devanahalli, Bengaluru do hereby notify the below mentioned premises as "Customs Area" in respect of M/s. Express Industry Council of India, located at Plot No. C-19, Express Cargo Terminal, Kempegowda International Airport, Bengaluru, measuring 15,761 sq.ft:
