Minutes of the PTFC Meeting

Shri Amitesh Bharat Singh, Commissioner of City Customs, Bengaluru, presided over the 2 nd Permanent Trade Facilitation Committee (PTFC) meeting held on July, 15, 2024.

- 1. The meeting began with a welcome address by Commissioner Shri Amitesh Bharat Singh of City Customs, Bengaluru, where he extended his greetings to all attendees.
- 2. The following matters were discussed during the meeting:

During the meeting, Mr. V Chandra Kumar - ACFI, Bengaluru, raised a concern about M/s. Pentair Technical Products India Pvt. Ltd. receiving two Orders in Original for the same issue. The Additional Commissioner clarified that the first OIO was based on CRA objections, resulting in a penalty of Rs. 20,000, which was paid. A second SCN was issued due to non-filing of returns and missing documents for the subsequent period. M/s. Pentair requested cancellation of their PBWH License, but NOC from AP, ACC, and ICD is pending. ICD reported issues with closing WH Bonds due to balances in BOEs and has requested additional documents.

The Commissioner clarified that adherence to NOC procedures and compliance with notifications were necessary and directed ADC (HQ) to make a written communication detailing the issue and requesting the completion of pending action to resolve the issue.

With no further matters to discuss, the Chairman expressed his gratitude to all participants and brought the meeting to a close.
