Kind attention of all the taxpayers, stakeholders, Custom Brokers, Exporters, Importers is invited to the Public Notice No.44/2020 dated 01.09.2020, addendum dated 27.11.2020 and Corrigendum dated 06.01.2021 regarding creation of Warehousing Monitoring Cell (WMC) at Headquarters of Bangalore City Customs Commissionerate, Bengaluru.

At Para 2 of the corrigendum dated 06.01.2021 to the Public Notice No.44/2020 dated 01.09.2020, it was informed about creation of Warehouses Monitoring Cell (WMC) at Headquarters attached to the Technical Section, Head Quarters, City Customs Commissionerate comprising of Officers (in the rank of Superintendent) designated as Bond Officer in terms of Regulation 2(1)(b) of Warehouse (Custody and Handling of Goods) Regulations, 2016 and 2(1) (ii) of Manufacture and Other Operations in Warehouse (no. 2) Regulations, 2019, whose functions differ from that of Bond officer at Port (ICD) and their functions were defined in Annexure I & II enclosed to that corrigendum.”
