**NOTIFICATION No. 01/2025-AP & ACC BLR**

In exercise of the powers conferred upon the Principal Commissioner of Customs or Commissioner of Customs, as the case may be under Section 8(a) of the Customs Act, 1962, I, Debashish Sahu, Principal Commissioner of Customs, Airport and Air Cargo Complex Commissionerate, Devanahalli, Bengaluru, hereby approve the below mentioned premises as "Customs Area" in respect of Air Force Station, Yelahanka, Bengaluru, for unloading and loading, handling, storage and transshipment of goods as a special case for the purpose of customs clearance support for the 15<sup>th</sup> edition of Air Show i.e., Aero India 2025.

**Description of the premises:**

2. In exercise of the powers conferred under Sub-section(b) of Section 8 of the Customs Act, 1962, I hereby specify the limits of the said Customs Area as under:-

Northern side : Suggatta Village and Government Private Lands.  
Western side : Railway Line and Nitte Meenakshi College Road.  
Southern side : BSF Campus.  
Eastern side : Bellary Road (National Highway).
