### **NOTIFICATION NO.02/2025-AP & ACC, BENGALURU**

In exercise of the powers conferred under Section 45(1) of the Customs Act, 1962, I, Debashish Sahu, Principal Commissioner of Customs, Air Customs Commissionerate, Bengaluru do hereby appoint "M/s Hindustan Aeronautics Limited" to be the Custodian of the goods meant for import/ export at Air Force Station, Yelahanka, Bengaluru as notified under Section 8(b) of the Customs Act, 1962, for the purpose of unloading of imported cargo and loading of export cargo brought at the said premises till they are either cleared for home consumption or exported or warehoused or transhipped in accordance with the provisions of the said Act and subject to the following conditions from 20.01.2025 to 28.02.2025.

1. The Custodian of the goods meant for import and export would be required to comply with the provisions of Section 45 and other relevant Sections of Customs Act, 1962 and Rules & Regulations made there under as well as instructions issued from time to time in this regard.

2. The Custodian shall be responsible for the proper receipt, handling, storage and shall be accountable for the loss of goods either imported or those meant for export or transshipment after their receipt and before Customs clearance / re-export. The Custodian shall maintain proper record of all such goods including those disposed off under Section 48 or otherwise.
3. If any imported/export/transshipment goods are pilfered or lost after unloading in the Customs Area and while in the custody of the Custodian, then the Custodian shall be liable to pay applicable customs duty, cess etc. on such pilfered / lost goods in terms of provisions of section 45(3) of the Customs Act, 1962.
4. Custodians shall be responsible for any improper removal of imported/export goods and shall be liable to pay appropriate customs duty, cess, etc on such improper removals in terms of Customs Act 1962.
5. The Custodian would also be responsible for the goods lost during the transshipment from the said Customs Area to the gateway port /other Customs Area and shall have to pay appropriate customs duty, cess etc. as per provisions of Customs Act 1962.
6. The imported/export/transshipment goods, which are not cleared for their intended purpose within 30 days or within the extended period as the Proper Officer may allow, or in case of relinquishment of title by the importer in terms of Section 23(2) of the Customs Act, 1962, such goods shall not be sold without obtaining permission from the Proper Officer of Customs under the provisions of the Section 48 of the Customs Act, 1962.
7. The Custodian shall provide safe, secure and spacious place for loading/unloading/storage of the cargo.
8. The limits of operation area of the custodian are bounded by the following landmarks and the same is main exhibition and display area for Aero India -2025.

Northern side: Suggatta Village and Government / Private Lands.  
Western Side: Railway Village and Nitte Meenakshi College Road.  
Southern Side: BSF Campus  
Eastern Side: Bellary Road (National Highway)

Beyond this area the movement of any foreigners or exhibitors and their cargo is not permitted. The Custodian shall provide sufficient modern handling equipment in operational condition for handling the cargo in the notified area.

9. The Custodian shall provide suitable office space for Customs Officers for performing their duty for Aero India Show -2025. Uninterrupted thoroughfare shall be provided to the customs officials in the Customs Area. The Custodian shall make adequate arrangements for sanitary facility, water supply and other facilities including canteen facility for the officers working in the Air Force Station, Yelahanka. Free transport facility shall be provided by the custodian for the customs staff posted at the Air Force Station, Yelahanka.

10. Custodian shall not charge any rent/ demurrage for the goods detained by the customs officials during the subject period.

11. In case the Custodian intends to sublet any of the functions to any entity within the Customs Area or connected thereto, such subletting shall be undertaken only with the prior approval of the Principal Commissioner of Customs. The Custodian shall remain responsible for all acts of omission and commission by the said entity.
