STANDING ORDER. 01/2025

Subject: 15thInternational Exhibition – Aero India 2025 at Air Force Station,
Yelahanka, Bengaluru from 10.02.2025 to 14.02.2025 – Reg.

The 15th International Aerospace Exhibition – Aero India 2025, shall be held at Air Force Station, Yelahanka, Bengaluru from 10.02.2025 to 14.02.2025. The Board vide letter F.No.520/06/2016-Cus – VI(Pt 1) dated 13.11.2024, granted special permission under section 29(1) of Customs Act 1962 for providing all customs clearance facilitation support from 20.01.2025 to 28.02.2025 at Air Force Station, Yelahanka, Bengaluru for the Aero India 2025, subject to observance of relevant Rules, Regulations and procedures prescribed under the law.

(2) In this background, following instructions are issued for compliance:

The authorized agent or the Pilot-in-Command of all the Aircrafts that are coming for participation in the Aero India Show, 2025 should file the General Declaration- Inward in duplicate along with the Annexure furnishing the details of parts/accessories/tools/consumables that are being brought in the Aircraft. Original copy shall be retained by the Customs and the duplicate copy is required to be handed over to the authorized agent or the Pilot-in-Command. A running serial number should be given to each General Declaration so filed, which shall be treated as Import General Manifest, by the Proper Officer of Customs and details mentioned therein should be entered in a separate register.

(1) At the time of departure of the Aircraft, after the completion of the Aero India Show 2025, the authorized agent or the Pilot-in-Command should file a General

Declaration-Outward in duplicate. A running serial number should be given to each General Declaration so filed, which shall be treated as Export General Manifest, by the Proper Officer of Customs, and the details therein should be entered in the aforesaid register. The details contained in the General Declaration-Outward should be verified with the details contained in General Declaration-Inward.

- (2) All the spares/accessories/tools/consumables (hereinafter referred to as 'Goods') which are brought in, as declared in General Declaration- Inward should ordinarily be re-exported and so indicated in the General Declaration-Outward, filed in this behalf. However, in the event of non-export of any goods, the same would be assessed to customs duty as applicable. In such an eventuality, necessary Bill of Entry corresponding to the goods shall be filed manually, assessed by the Proper Officer and appropriate customs duty shall be required to be paid. In cases where the goods have been stated as used in the Aircraft for replacement/maintenance, the Proper Officer should corroborate and confirm that the same have been so used for the purpose so stated.
- (3) The Aviation Turbine Fuel consumed by the aircraft participating in the Aero India Show, 2025 at the Air Force Station, Yelahanka, is subject to applicable customs duty, cess etc. which is required to be paid before the departure of aircraft.
- (4) It will be the responsibility of the Deputy/Assistant Commissioner in charge to ensure that all the records are maintained properly and applicable duty and other dues are collected in time as per provisions of Customs Act 1962.
- (5) All Officers deputed will be required to strictly follow relevant Rules, Regulations etc., as per provisions of Customs Act 1962.
