2. Shri. Biju Thomas, Additional Commissioner, Customs Commissionerate, Mangaluru, commenced the proceedings by welcoming all the members/ participants.

3. Under the 1st agenda point, Shri. C. G. Prashant, Manager, Interocean Shipping Pvt. Ltd., brought to the department's attention that the long-pending SDM amendment issue is yet to be resolved. In response, Shri. A. Haridas, Assistant Commissioner (EGM/IGM) informed that matter has already been taken up with the DG Systems and Data Management, CBIC, New Delhi, vide letter dated 29.08.2025, followed by reminder letters dated 26.09.2025 and 23.10.2025. He further stated that he has personally contacted the DG Systems officials and apprised them of the difficulties being faced by the trade due to the delay.

4. No additional agenda points were raised during the meeting. The meeting concluded with a brief presentation by Shri Mohammed Imran of M/s Balaji Malts Pvt. Ltd., who outlined the company's business prospects in Mangaluru, particularly its stock-and-sale trade operations, and provided an overview of the coal sector scenario in the Mangaluru region.
