2. Shri. Vishnu Diwakar, Inspector, Customs Commissionerate, Mangaluru, commenced the proceedings by welcoming all the participants.

3. Shri. Philip C.C., President, CHA Association, elaborated on the agenda item raised by the Association regarding the non-renewal of the lease agreement in respect of the CWC-operated CFS situated on leased land allotted by NMPA. He informed that the existing lease agreement is due to expire on 31.12.2025 and the same is not extended beyond the said date. He requested the Chairperson to take up the matter with NMPA for renewal of the lease agreement or to explore alternate arrangements, so that CFS operations are not adversely affected.

4. In response, the Chairperson clarified that since the matter pertains to CWC and NMPA, no direct action can be taken from the Department at this stage. However, the Chairperson informed that the representation received from the CHA Association would be forwarded to NMPA from the Department's end for consideration and possible resolution.

5. No further agenda points were raised during the meeting.
