2. Shri. Vishnu Divakar, Inspector, commenced the proceedings by welcoming all the members/ participants.

3. As no agenda items were received prior to the meeting, the trade representatives were invited to raise any issues being faced by them.
4. Shri Philip C.C., President, CHA Association, re-iterated the request that they had raised in the previous PTFC meetings, regarding the conduct of G-Card examination at Mangalore Customs Commissionerate. In response, the Chairperson informed that necessary action would be taken in the matter.

Further, Shri Adarsh K., Assistant Director General of Foreign Trade (DGFT), Bengaluru, apprised the forum that under the Districts as Export Hubs (DEH) initiative of DGFT, 120 districts have been identified as priority districts, including Dakshina Kannada, which falls under the jurisdiction of Mangaluru Customs Commissionerate. He further informed that a physical meeting of exporters from Dakshina Kannada has been scheduled for 10.07.2026 and requested active participation and cooperation from Customs during the event. The Chairperson assured him that all necessary support and cooperation would be extended by the Commissionerate.
