Minutes of the 31st Permanent Trade Facilitation Committee (PTFC) meeting held on 14.07.2026

The Permanent Trade Facilitation Committee (PTFC) was constituted vide Circular dated 07.01.2022. The 31st meeting of the PTFC was held on 14.07.2026 in hybrid mode. Shri. Abilash K. 2. Shri. Harikrishnan, D., Joint Commissioner of Customs, commenced the proceedings by welcoming all the members/ participants.

3. Mangalore Steamer Agents Association, represented by Sri. Prashanth C.G., Secretary, proposed the following 2 points for the discussion during the meeting, vide their e-mail dated 13.07.2026. He raised the said issues in the meeting also.

3.1. While filing Sea Departure Manifest (SDM) as per the SCMT Regulations, they received a success message, but cargo status in Shipping Bill inquiry at ICEGATE is not reflecting the cargo: Sri. Prashanth C.G. informed that they submitted SDM and SDN for vessel AURORA-I and received a success report. However, the cargo details were not getting reflected under ICEGATE EGM enquiry. The details are as under:
IMO No. :9629691 , Shipping Bill No. : 3263134 dated 15.05.26, SDM filed on: 23.06.26, SDN filed on : 24.06.26, Status : Success;-

However, upon enquiry in ICEGATE against the said Shipping Bill Number, the current status of EGM is being shown as EGM as against HIST for successful filing of SDM/SDN.

Discussions: The details of the ticket raised for this issue may be shared for further resolution of the matter.

3.2. After vessels sailing, if there is a necessity to amend the IGM due to excess quantity discharge, the same may be allowed at EDI section using EDI 1.5 version: Sri. Prashanth C.G. raised the issue and stated that with the transfer of the officer, currently no officer was allotted the said work. Sri. Anish, M/s. Ocean Network Express (India) Pvt. Ltd., also requested to allow the said amendment.

Discussions: Shri. Harikrishnan, D., Joint Commissioner of Customs, informed that such amendments can be carried out online modules by Streamer Agents themselves. With the discontinuation of the EDI service centre, the Streamer Agents themselves have to carry out such amendments with the online module. The Service Centre role mapping is not allowed by DG Systems for officers in the grade of Inspectors and above. Meanwhile, interim arrangements will be tried with DG Systems. The Chairman informed them to raise a ticket for the issues relating to the online module so that the same can be taken up with DG Systems for resolution.

4. No other agenda points were raised during the meeting. Shri. Harikrishnan, D., Joint Commissioner of Customs, thanked all the participants for joining the meeting.
