2. Shri. Harikrishnan, D., Joint Commissioner of Customs, commenced the proceedings by welcoming all the members/ participants.

3. Mangalore Customs Brokers Association, represented by Sri. Philip C. C., President, proposed the issue of conducting 'G' card examination at Mangalore Customs Commissionerate for the discussion during the meeting, vide their e-mail dated 23.07.2026. He raised the said issue in the meeting also and reiterated that many candidates are willing to appear for the said examination, which was not conducted for a long time. In this regard, Shri. Harikrishnan, D., Joint Commissioner of Customs, informed that this issue was discussed in the earlier PTFC meeting and the proposal for conducting the examination has already been forwarded to the Office of the Chief Commissioner of Customs, Bengaluru Zone. The Chairman asked to furnish a comprehensive proposal with the details of the number of persons currently holding 'G' card, justification for additional 'G' card holders and the number of candidates likely to appear for the examination. Sri. Philip C.C. informed that the details had already been shared and agreed to provide the same again for further pursuing the matter.
